2. Bidders are requested to study the terms and conditions of the tender carefully and then submit tenders accordingly.
3. The bidders shall submit duly filled and completed bidding document ONLINE as per instruction contained in the bidding documents. Incomplete bid shall be rejected. The conditions of tender shall be governed by the details contained in complete bid document.
4. The rates should be quoted as per the BOQ uploaded on the CPP Portal. Taxes, if any, should be indicated separately. ### **10. Evaluation of the quotation:-**

- a. Every bid will be examined to determine whether it qualifies for all the requirements with respect to documents sought through this bid.
- b. All bids which will qualify in above examination will be examined for their qualification as responsive bidder to determine whether their bid satisfies the parameter for technical qualification for the job as mentioned in this bidding document.
- c. Financial bid of all bidders which will qualify in the Technical evaluation as responsive bid will be opened.
- d. Order will be placed to the lowest quoted responsive bidder for the whole job.

**11. Risk Clause and termination:** Institute reserves the right to discontinue the job at any time, if the services are found unsatisfactory by giving a Show-cause Notice to be replied within a week and also has the right to award the contract to any other agency at the risk and cost of current agency and excess expenditure incurred on account of this can be recovered from Security Deposit or pending bills or by raising a separate claim.

- a. This contract can be terminated by giving one month's notice on either side and that any notice required to be served shall be sufficiently served on the parties, if delivered to them personally or dispatched at the mentioned address through registered post. Payment upto completed part of job shall be paid by the institute in case it is terminated by this Institute. If contract is terminated by bidder, payment will be made for the completed part of job after due evaluation of the job by the institute.

**12. Loss and / or damages:-** In case of any loss or damage is done by any worker of the agency to the property of MGIFRI, Motihari, full damages will be recovered from the successful bidder.

**13. Subletting of job:-** The contractor shall not sublet the job without prior written permission of the Institute. In case the contractor intends to sublet the job to some sub-contractor, the contractor must furnish prior information to this effect, in its bid itself; in that case, the sub-contractor, too, must fulfil all the requirements to be fulfilled by the Contractor as per the terms and conditions of this contract.

**14. Recovery of loss/dues** -For loss or damage or theft etc., if any is noticed due to negligence on the part of the firm, the agency shall meet the cost and also be required to compensate such loss for which the agency has to execute an Indemnity

bond of appropriate value on on-judicial paper against any loss of MGIFRI property, assets and immovable/movable properties.

15. **Legal Obligations:**-All personnel/ staff employed by the successful bidder shall be engaged by him as his own staff in all respects express or implied. The responsibilities whatsoever, incidental or direct, arising out of or for compliance with or enforcement of the provisions of various Labour Laws/Industrial Laws of the country, shall be that of the contractor. - 3. Evaluation of bids:** In the case of tie in price quoted, preference will be accorded to the firm which will have the larger number years of job experience in Government organisation. - 4.
